Since the second summit of the Berlin Process in Austria in 2015, the **Civil Society & Think Tank Forum** has become an integral part of the Berlin Process, involving civil society to contribute their ideas to advance cooperation and integration in the Western Balkans.

At the 10th anniversary of the Berlin Process, the Civil Society & Think Tank Forum 2024 again empowers thematic working groups to discuss current issues and produce policy recommendations. Civil society representatives have the opportunity to provide input and strengthen their visibility in the Berlin Process, while formulating and discussing recommendations that inform key stakeholders.

During the **Preparatory Forum** in July in Skopje, civil society representatives developed policy recommendations within seven thematic working groups. The results of the Preparatory Forum will serve as input to the **Civil Society & Think Tank Forum** in Berlin, which takes place just a few days before the Berlin Process Leaders' Summit on October 14, 2024. At the Forum in Berlin, perspectives of civil society and think tanks will be presented and discussed directly with decision-makers from the region and the EU.

The social and economic inclusion of minorities in all aspects of public life is a key goal of the Berlin Process. In 2019 the Declaration on Roma Integration saw the governments of the Western Balkans commit to a clearly defined set of common objectives towards “full equality and integration of Roma”. However, much remains to be done to ensure that marginalized communities can benefit from the same rights and opportunities as the rest of the population. The spotlight discussion will address the following questions. What are some of the biggest barriers faced by marginalized communities in accessing equal rights and opportunities in the region? How can the Western Balkans cooperate to empower minorities across the region and which role can the Berlin Process play in this regard? What can be done to ensure that future reforms remain rooted in marginalized groups’ needs and perspectives? How can civil society most effectively advocate for the rights of minorities at multiple levels?

The signing of the Green Agenda in 2020 marked an important step in aligning the region's climate and energy targets with the objectives of the European Green Deal. However, the implementation of energy policies and climate legislation remains a challenge in the region. The panel will focus on the following issues: What are the biggest challenges the region faces when it comes to green energy transition and how to address them? Which role should the Berlin Process and the EU play in this regard? What can be done to ensure that the issue gains more visibility in the eyes of decision-makers? How can coal-dependent regions be supported in the green energy transition? What can be done to better include relevant CSOs and experts in the transition process?
